### **From: Long Island Expressway / Northern State Parkway**

- LIE Exit 41 South - Make RIGHT off exit, heading south, onto Routes 106/107
- Northern State Parkway Exit 35 South - Make RIGHT off exit, heading south, onto Routes 106/107

**From BOTH the LIE & the Northern State Parkway, proceed south approximately 1 mile.**

- As you pass Ikea on your right, the road will fork
- Bear RIGHT onto Route 106 (Newbridge Road)
- After passing under the elevated railroad overpass, go to the 3rd block (counting on your RIGHT)
- Turn RIGHT onto W. Nicholai Street (at the gas station)
- Go the 8th house on the right, 184 W. Nicholai Street, a brick-front ranch with a large dog toy in the front window and a silver car with the license plate PROVOICE in the driveway.
- Street parking is available; please **DO NOT** block any driveways or vehicles.
- **The entrance to the office is on the LEFT side of the house. When you arrive, ring the gold Ring doorbell to the LEFT of the entrance door on the LEFT side of the house and wait to be identified. Once staff identifies you, they will ask you to come in. Once you enter, the steps down to the waiting room are immediately to your right.**

### **From: Southern State Parkway (traveling eastbound)**

- Go to Wantagh Parkway North (Exit 27-N)
- Go North on Wantagh Parkway to Exit W2-E, Old Country Road, towards Hicksville
- Travel East on Old Country Road 1.3 miles to Newbridge Road/Route 106
- Turn LEFT onto Newbridge Road/Route 106
- Go to the 1<sup>st</sup> intersection past the CVS shopping center & make a LEFT at the gas station onto W. Nicholai Street
- Go the 8th house on the right, 184 W. Nicholai Street, a brick-front ranch with a large dog toy in the front window and a silver car with the license plate PROVOICE in the driveway.
- Street parking is available; please **DO NOT** block any driveways or vehicles.

- The entrance to the office is on the **LEFT** side of the house. **From: Southern State Parkway (travelling westbound)**

- Go to Seaford-Oyster Bay Expressway / Route 135-N (Exit 28A--N)
- Go to Exit 10, Old Country Road - West
- Make a LEFT at the top of the exit ramp onto Old Country Road, towards Hicksville
- Proceed 2.6 miles to Newbridge Road / Route 106
- Turn RIGHT onto Newbridge Road/Route 106
- Go to the 1<sup>st</sup> intersection past the CVS shopping center & make a LEFT at the gas station onto W. Nicholai Street
- Go the 8th house on the right, 184 W. Nicholai Street, a brick-front ranch with a large dog toy in the front window and a silver car with the license plate PROVOICE in the driveway.
- Street parking is available; please **DO NOT** block any driveways or vehicles.
- The entrance to the office is on the **LEFT** side of the house.
